

#### 6. BOARD MEMBERS' REPORTS

Vice-Chair Mizell reports the following:

 He has had a conversation with the City Attorney's office and Anthony Rodriguez of the Mayor's office regarding a memo seeking to analyze the

- charter and PAB powers. Board should expect to have an answer in the next couple of weeks, likely to be in a confidential format.
- He has received a communication from the City Manager's office regarding the Police Chief hiring process. Has been invited to the interview panel for Thursday, October 6<sup>th</sup> from 1- 5 pm. He is concerned if the hiring process for the new police chief has followed the charter. Suggests PAB should have a discussion to look into this matter.

#### In response to Vice-Chair Mizell's report:

- Board members share concerns about the PAB's involvement in the hiring process of the police chief and being bypassed in other important processes.
- Deputy City Attorney James Chang advises the Board that they must schedule a special meeting to be able to convene about the PAB's next steps in regard to the Police Chief hiring process. Notes 24-hour notice must be provided.

Vice Chair Mizell steps away from the meeting, new PAB Chair Moore takes over the meeting.

#### 7. CHIEF OF POLICE'S REPORT

- Lt. Daniel Montgomery reported:
- Oakland Police Department (OPD) had a shooting incident near a school. It
  was initially thought to be a school shooting so OPD called for emergency
  support. Berkeley Police Department (BPD) was able to aid but were called off
  when further information revealed the shooting was near the school and it was
  not an active shooter situation.
- On a related noted, all BPD officers are being updated on active shooter training to make sure department is prepared.
- Statistics on gun related crime through August of 2022 will be shared with the public soon.
- BPD continues to have staffing issues. Currently have 150 offices from which 13 officers are injured, 3 are still in the academy, and there are several other leaves. BPD only has 130 officers currently available.
- Only 7 new applicants for BPD jobs. No current incentives.
