# 5 Year Street Rehabilitation Plan

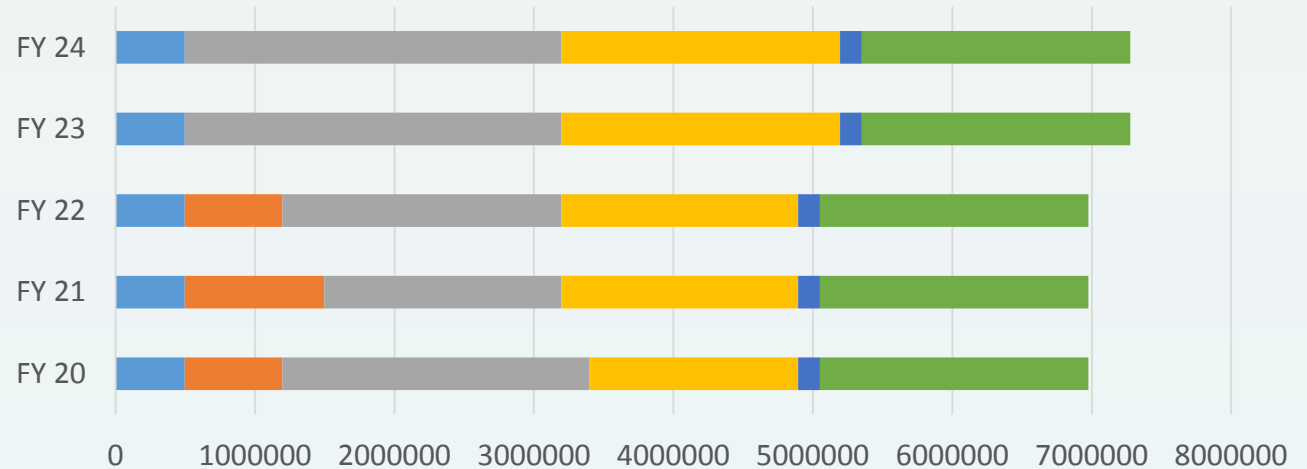

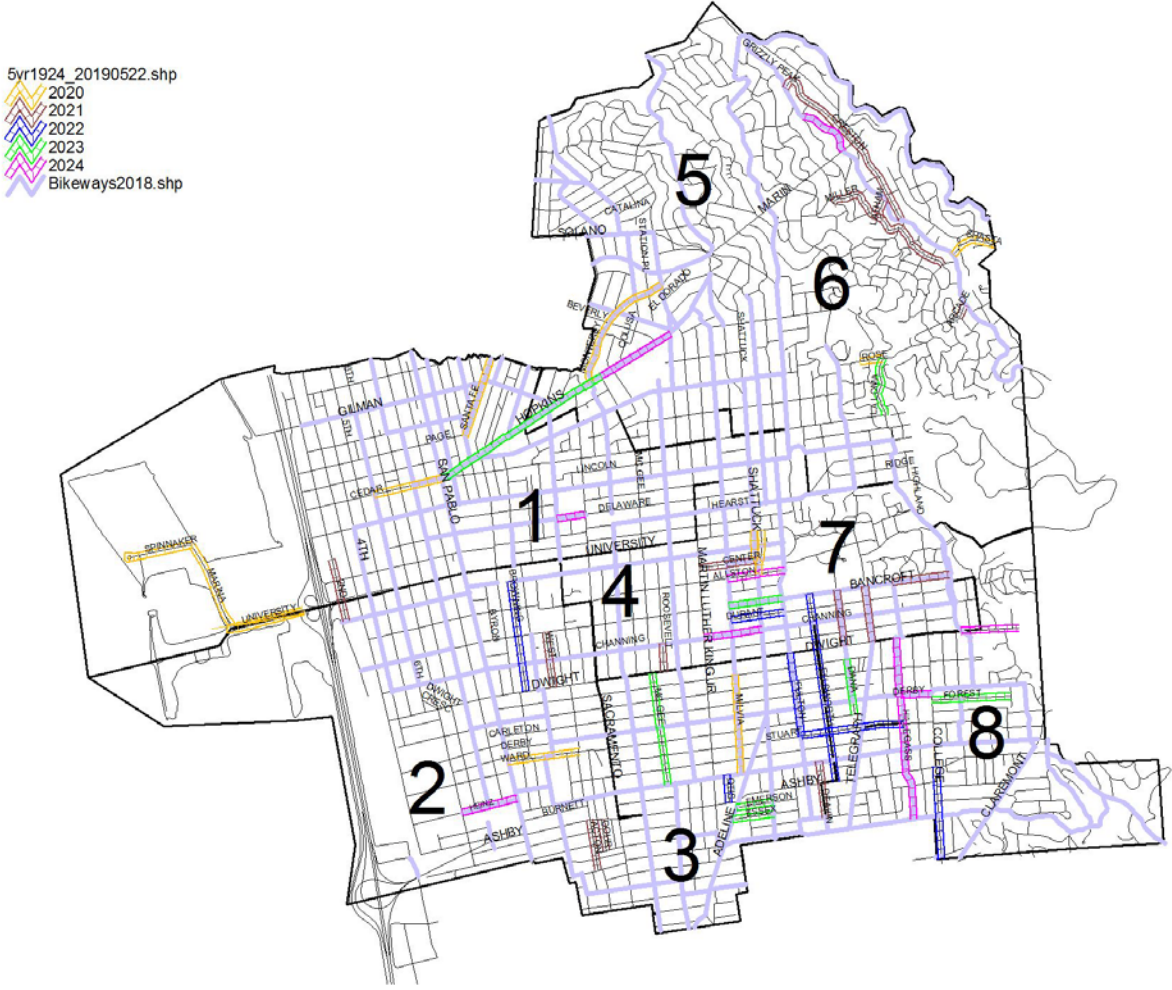

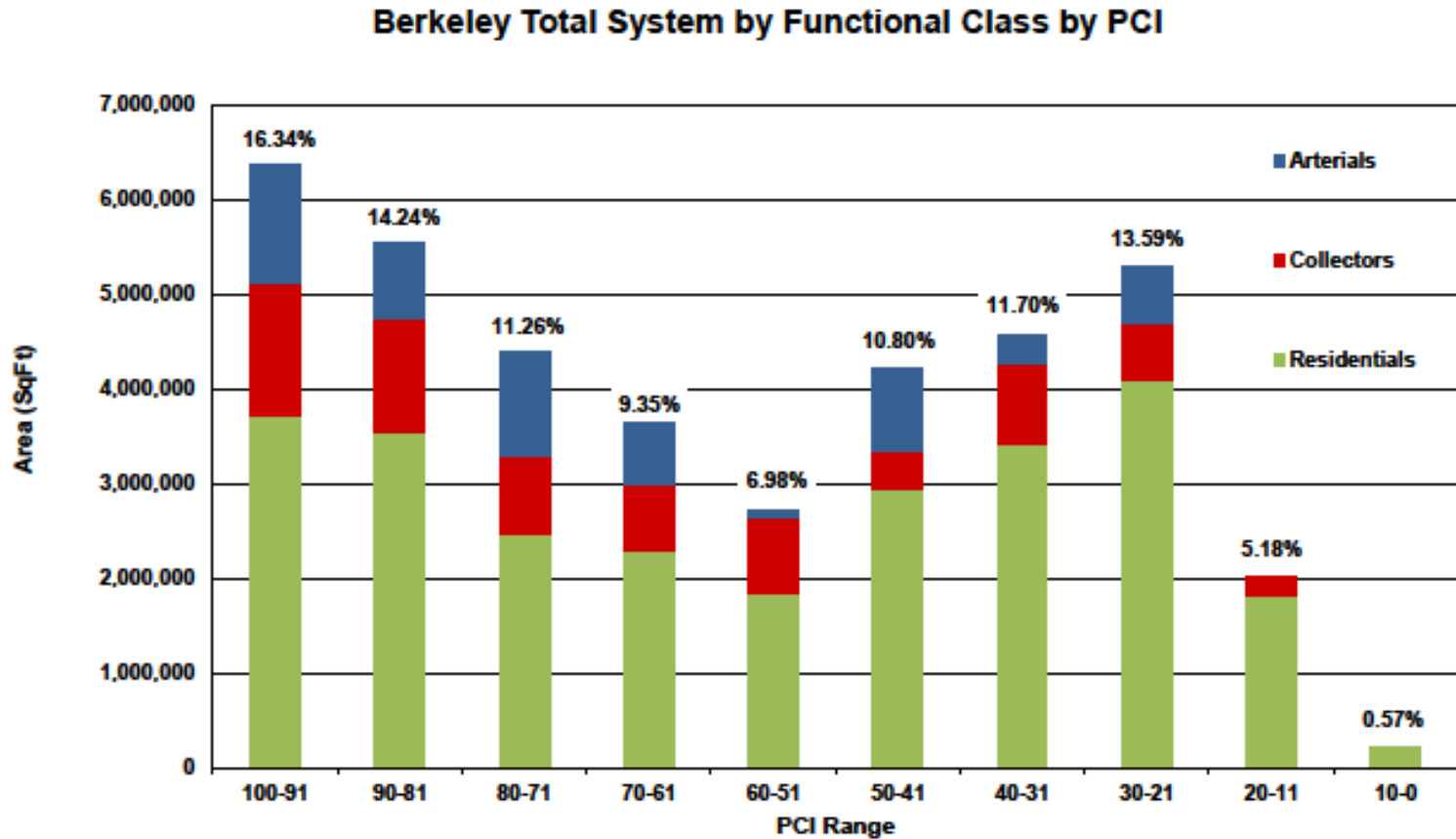
